The standards required to consider the level of inactivation sufficient were also agreed. The possible layout and contents of the opinion were agreed in line with the assessment and sub-assessment questions.

Using the current draft of the protocol the working group discussed and amended the assessment questions reflecting the different aspects of the assessment: the criteria for the determination of the relevant pathogens that can be used as indicators to assess the efficacy of standard processing methods for Category 3 ABP of porcine origin (AQ1); the technical parameters (e.g., time, temperature, pressure, pH, particle size) of methods 2-5 and 7 (AQ2); the thermal inactivation parameters of the relevant pathogens identified AQ1 (AQ3); the level of inactivation of the selected relevant pathogens achieved by methods 2-5 and 7 (AQ4); the certainty that the level of inactivation achieved by methods 2-3-4-5 and 7 as in AQ4 is sufficient to reach the standards for Category 3 ABP (AQ5). The standards required to consider the level of inactivation sufficient were also agreed. The possible layout and contents of the opinion were agreed in line with the assessment and sub-assessment questions.
