presenting HCD for endpoints in reproductive toxicity and developmental toxicity studies were developed. The Panel endorsed the draft Opinion that will be published early in March for public consultation. The Panel was informed that an info-session is under preparation with the aim to elucidate the content of the draft Opinion (in particular the proposed approach) and it will be published at launching of the public consultation.

4.2. Draft opinion concerning the basic substances chitosan and chitosan hydrochloride (EFSA-Q-2024-00037)

The Panel was updated on the mandate received from the European Commission. Legislative framework for the request and terms of reference were presented as well as the planning of activities. Following an analysis done in consultation with the chair of the Panel, it was agreed that the mandate will be carried out by a new WG. The chair will be Roberto Lava from the chemistry and environmental exposure team of the PLANTS Unit.

5. EFSA technical report on Development of a DNT AOP using voltage gate sodium channel inhibition as a molecular initiating event (EFSA-Q-2021-00443)

The Panel was updated on the recent progresses made by the WG. The Report will be finalised and presented during the plenary meeting in April for possible endorsement by the PPR Panel.
