5. Agreement of the minutes of the 126th PPR Plenary held on 19-20 April 2024, via web-conference

The minutes of the 126th PPR Plenary were agreed by the member of the previous Panel via written procedure on 10th July.

6. PPR Panel operations

The Panel was informed on:

- remit and main tasks of the Panel,
- main procedures for the peer review of pesticide active substances,
- · roles and responsibility of Panel members, Working Group members and EFSA staff.

The Panel was also informed about the procedure for the election of chair and the 2 vice-chairs.

7. Scientific topic(s) for discussion

7.1. Draft opinion on Use and reporting historical control data (HCD) for regulatory studies (EFSA-Q-2021-00274)

The Panel was informed on the terms of reference of this mandate, main outcome of recent closed public consultation and planning with deadlines. The Panel was also updated on discussions held at the last Working Group meeting.

7.2. Draft opinion concerning the basic substances chitosan and chitosan hydrochloride (EFSA-Q-2024-00037)

The Panel was informed on the progress of the Working Group in addressing the terms of reference. Planning and dates of future meetings were also presented.

8. Chair Election

Panel members were invited to put forward their candidacy via mail before the plenary and orally before the election.

As chair, Tamara Coja was elected; the 2 vice-chairs are Silvia Pieper and Emily McVey.

9. Update on new mandates

9.1. Application of PBK modelling for the QIVIVE of DNT IVB data for pesticide active substances (EFSA-Q-2024-00299)

The Panel was updated on the self-task mandate for an activity on the use of PBK modelling for quantitative interpretation of Developmental Neurotoxicity (DNT) *In Vitro* Testing Battery (IVB) data. The Panel appointed one of the EFSA staff as chair of the Working Group.

9.2. Waiving the dog studies in the regulatory process for agrochemical approval (<u>EFSA-Q-2024-00199</u>)

The Panel was updated on the self-task mandate on the activity on the waiving of dog studies in the risk assessment of pesticides. The chair of the Working Group is Judy Choi.

9.3. Request for revision of terrestrial Ecotoxicology Guidance

The Panel was updated on the external mandates for (i) the revision of the existing SANCO Guidance on terrestrial ecotoxicology and (ii) for a methodology to assess indirect effects on biodiversity via trophic interactions under agro-environmental conditions. In view of this mandate, a call for expression of interest was launched to establish a pool of experts in the field and a workshop will be organised on 8-9 October with nominated MS, stakeholders and experts from this ERA WG.

9.4. Other possible mandates under negotiation

The Panel was informed on a mandate of the European Parliament on a request for a Scientific Opinion reviewing the literature on the methodologies available to study the long-term toxic and/or carcinogenic effects of PPPs, in particular those resulting from interactions between the components mixed in these products.

10. Overview on EFSA ongoing projects

EFSA staff informed the Panel on the on-going EFSA projects (including OPEX, PERA, CRA, Neurotoxicity, Brain Health, ED and Azole-resistant Aspergillus).
