

# FEEDBACK FROM MEMBER STATES IUCLID PSN MEETING 11-12 JUNE 2024



## Notification of studies:

1. It is unclear to DE and to many applicants, which date is binding as the "study start" of a study for notifying in 'EFSA's database of study of notification'? The information in Article 2, letter (e) of the EFSA Practical Arrangements on pre-submission phase and public consultations and in "Questions and Answers on EFSA Practical Arrangements" is not sufficient. Is the date of signature of the study plan by the study director, the date of the audit of the study plan or the experimental start date?

In the context of the admissibility check, the relevant regulatory body must ensure the compliance of the application with the obligations of study notification, including the obligation that the studies were notified before the starting date.

Different dates included in a study report may be considered for the starting date. The examples in the following slides show for three different studies the date included in the dossier as the starting date and screenshots of the various dates available in the study reports, which might be considered.



## Notification of studies:

 Article 2, letter (e) of the EFSA Practical Arrangements on pre-submission phase and public consultations:

"Starting date of a study" means the experimental starting date, that is to say, the date on which the first study-specific data are expected to be collected; in the specific case where the experimental starting date is difficult to estimate, the starting date of a study is determined as follows:

- (i) for studies conducted according to an established protocol, the starting date of a study means the date of signature of this protocol;
- (ii) for studies not conducted according to an established protocol, the starting date of a study means the date of definition of the study plan.
