5. Work-program of the FCM Panel 2024-2029

The Panel coordinator presented the remit of the FCM Panel, gave an overview of its organisation and presented the work program for 2024.

A presentation showing the procedures for assessing FCM applications was given to the Panel.

Each Working Group (WG) coordinator presented the main activities of the WGs of the FCM Panel, specifically: WG on Food Contact Material (FCM WG), WG on Recycling plastics (REC WG), WG on the evaluation of substances used to reduce microbial contamination from products of animal origin (Decontamination WG), WG on Extraction solvents (EXT SOL WG) and WG on preparation for reevaluation of phthalates, structurally similar substances and replacement substances (Phthalates WG).

The Head of Unit presented the respective roles and responsibilities of experts and staff throughout the risk assessment process and illustrated the main challenges foreseen for the FCM Panel.

6. Election of Chair and Vice-Chairs of the Panel

The election of the Chair and the two Vice-Chairs took place following the guidelines laid down in the EFSA implementing rule of the Management Board concerning the establishment and operations of the Scientific Committee, Scientific Panels and of their Working Groups³.

Claude Lambré was elected Chair of the FCM Panel; Maria Rosaria Milana and Els van Hoeck were elected Vice-Chairs of the FCM Panel.

Scientific outputs submitted for discussion and possible adoption

Interests and actions resulting from the Oral Declaration of Interest done at the beginning of the meeting

With regard to this meeting, Dr. Evgenia Lampi declared that she was appointed to participate to a Working Party on exposure assessment under the remit of the Organisation for Economic Co-Operation Development (OECD). The focus of this working party is on the development of Emission Scenario Documents (EDS) on the estimation releases of chemicals to the environment (Environmental Hazard/Risk Assessment). In accordance with EFSA's Policy on Independence¹ and the Decision of the Executive Director on Competing Interest Management², and taking into account the specific matters discussed at the meeting in question, the interest above was not deemed to represent a Conflict of Interest for the expert concerned.
