1. WELCOME AND APOLOGIES FOR ABSENCE

The chair opened the meeting and welcomed all the participants to the 5th plenary meeting of the FEEDAP Panel. Members not able to attend the meeting had sent their apologies (see under participants).

2. DECLARATIONS OF INTEREST

There were no interests declared relevant to the items on the agenda.

3. ADOPTION OF THE AGENDA

The agenda was adopted after some modifications which are reflected in the minutes.

4. ADOPTION OF THE DRAFT MINUTES OF THE 4TH PLENARY MEETING ON 22-23/10/2003

The minutes of the fourth plenary meeting of the Scientific Panel held on 22-23 October 2003 were adopted with minor modifications. The adopted minutes of the 3rd plenary meeting were distributed to all members.

5. GENERAL INFORMATION FROM EFSA

The panel was informed that EFSA will probably soon launch a new call for expression of interest for additional experts to the scientific panels in order to re-enforce the Panels. Maximum number of experts is fixed to 21 by the management board. It appeared that an environmental expert might be beneficial in complementing the existing expertise of the members in the FEEDAP Panel.

The scientific co-ordinator noted that the representation of *ad hoc* experts in working groups of FEEDAP Panel is quite low in comparison with the other Panels, this number could be increased in the future.

6. WORK PROGRAM

6.1. Discussion and possible adoption of scientific opinions

- Re-evaluation of coccidiostat Stenorol (halofuginone hydrobromide) in accordance with article 9G of Directive 70/524/EEC

The Rapporteur of the Working Group introduced the revised draft summary and conclusions for discussion and adoption. After a short discussion the final draft of the document was adopted subject to some editorial modifications.

- Re-evaluation of coccidiostat Deccox (decoquinate) in accordance with article 9G of Directive 70/524/EEC

The Rapporteur of the Working Group introduced the draft document to the plenary. The Panel reviewed the report in detail. The Rapporteur together with Working Group members were requested to amend the document according to the minor remarks made on this draft opinion. A revised document should be adopted by written procedure.

- Evaluation of coccidiostat Koffogran (nicarbazin)

The Rapporteur of the Working Group introduced the draft document. The Panel reviewed the report in detail. The Rapporteur together with Working Group members were requested to amend the document according to the remarks made on this draft opinion. A revised document should be circulated before the December plenary and then presented for adoption.

- Yea Sacc for leisure horses

The Rapporteur from the Working Group on Micro-organisms introduced the draft document for discussion. The safety of this additive (micro-organism product based on yeast *Saccaromyces cerevisiae*) for new target species (leisure horses) was focussed on in the assessment. Yea-Sacc was considered safe for use as feed additive to adult leisure horses but since no data were presented for suckling foals and young horses, FEEDAP Panel was not able to assess the safety of the extension to foals until two months post weanling. The document was discussed and adopted after minor modifications.

- Bioplus 2B

The Rapporteur from the Working Group on Micro-organisms introduced the question and the draft opinion for discussion. The Panel could not conclude on the compatibility of this micro-organism product with with coccidiostat maduramicin for feed for chickens for fattening or for turkeys using the data presented in the company dossier. After a short discussion the opinion was adopted with only minor modifications to the draft.

6.2. Progress Reports on

- Re-evaluation of coccidiostats in accordance with article 9G of Directive 70/524/EEC

Four Working Group meetings before December plenary are scheduled for different working groups of coccidiostat products. Intensive work is being carried out by working groups and their members in order to complete as many assessments as possible before end of the year or by early next year.

- Micro-organisms

Next meeting of the Working Group is planned for December 16th.

- Enzymes

The meeting of the Working Group planned for November has been cancelled and another one is planned for December the 11th.

- Question on the safety of use of iodine in feedingstuffs

The Rapporteur of the Working Group introduced the work carried out since the last meeting. The group has identified a need for another expert to join to complete the Working Group with expertise required for the environmental part of the question. Another meeting is scheduled for December the 10th.

- Question on use of the synthetic sodium aluminium silicate (zeolite) for the reduction of risk of milk fever in dairy cows

The Panel was informed the work will start next year. In the meanwhile further questions to the originator of the request will be addressed to enable the scientific risk assessment to be carried out.

- Question on the assessment of the safety of all carotenoids authorised in 70/524/EEC

The Working Group has not been completed yet and the work will only start next year.
