4. Scientific topic(s) for discussion

4.1. EFSA's internal project on "The use of animal-based measures to assess animal welfare in the EU – state of art of the last 10 years of activities and analysis of the gaps"

EFSA's perspective and needs with regard to the use of ABMs to perform risk assessment of animal welfare have been presented and discussed.

A new approach to look at, and to think about, ABMs (thinking in new boxes) has been presented. The experts extensively discussed how to apply it to ABMs' scientific topics.

The results of the preparatory work on ABMs gaps' identification and analysis have been presented and discussed in detail. In particular the main gaps that have been discussed regarded the following questions:

- "Why do welfare scientists not standardise ABM terminology and measures?"
- "Why have welfare scientists still not provided the tools that users need?"
- "Why don't welfare scientists know more about the essential attributes of the ABM's they use?"
- "Why have ABMs not been more frequently taken up and standardised in practice outside welfare science?"

The experts discussed which relevant actions should be needed in order to fill the identified gaps and improve the use of ABMs among all the stakeholders.

Background, objectives and approach of the EFSA's internal project have been presented.

The proposals for addressing the objectives of the procurement for the preparatory work have been presented and discussed in detail:

- Sources identification within the five areas of interest (EU-funded projects, peer-reviewed papers, quality assurance schemes, EUlegislative acts and EU-training initiatives)
- Methodologies for assessing how the concept and the use of ABMs have penetrated the AW community in the EU (five areas of interest)
- Gaps' identification: data model, data extraction and gap analyses (EU-funded projects, peer-reviewed papers, quality assurance schemes).

Comments received by e-mail on these items in preparation of the meeting have been discussed and addressed.

Peer-reviewed papers to be considered in the study were identified by applying a codified literature search protocol and filtering for "animal welfare" firstly and "animal-based measures" (and synonyms), secondly. It was suggested to repeat the search by making the first search broader and disentangling the word "welfare" from the word "animal". A scoping exercise of the literature will be repeated and the number of records resulting will be compared to the results of the previous search. The data models have been considered very thorough, and the variable "country" has been considered nonfundamental information to be collected and analysed. It was suggested to highlight that the aim of the project regards mainly "the use of the concept of ABMs", whereas the gap identification and following analysis will regard both the concept of ABMs and specific ABMs.

The results of the gaps' identification will be discussed at the next WG meeting.
