5.1 Contributions to the scientific opinion "RONAFA" (Reduction Of the Need of Antimicrobial in Food producing Animals – scientific opinion led by the BIOHAZ Panel of EFSA) (M-2015-0081)<sup>3</sup>

AHAW contributions to chapter 1.8 on "Circumstances and diseases where AM are mostly used", chapter 3.2. on "Alternative options for reducing the need for AM" were discussed with special focus on chapter 3.2. on the alternative options linked to animal health and welfare. Separate paragraphs were produced on primary, secondary and tertiary prevention, including specific sections on herd health plans, housing, nutrition, level of stress, animal genetics, awareness raising, rethinking of the farming system and examples of successful stories. The chapters on vaccination and disease eradication were discussed and revised.
