Some specific issues were asked to the new expert regarding: a) the avian respiratory physiology on what concerns the effect of low atmosphere pressure; b) the welfare consequences of rapid decompression in chickens (terrestrial bird species that doesn't fly at high altitudes) and c) the current content of the opinion, mainly focusing on the areas related to his expertise.

In relation to the evaluation of the specific studies provided by the EC, the consequences of the intervention in respect to the poultry respiratory physiology and therefore, the impact on the animal welfare, were thoroughly addressed. The discussions will be reflected in the revision of the assessment.

The expert was asked to provide and share with the other experts any other article or study relevant for this mandate.

- The assessment will focus on the studies addressing the animal welfare implications of LAPS.
- The eligibility assessment of the studies and next steps were discussed, following the criteria for LAPS identified in the draft Guidance on the assessment criteria for studies evaluating the effectiveness of stunning interventions regarding animal protection at the time of killing.
