1. Welcome and apologies for absence

The Chair welcomed the participants.

2. Adoption of agenda

The agenda was adopted without changes.

3. Declarations of Interest of Working Groups members

In accordance with EFSA's Policy on Independence¹ and the Decision of the Executive Director on Competing Interest Management², EFSA screened the Annual Declarations of Interest filled out by the Working Group members invited to the present meeting. 4. Agreement of the minutes of the 24th Working Group meeting held on the 7th and 8th of November, HYBRID.

5. Scientific topic(s) for discussion4

5.1 Scientific opinion: Cold stress

The Working group discussed the temperature at which chickens start to experience cold stress and agreed on conclusions for cold stress in broilers in mobile housing systems.

5.2 Scientific Opinion: Gait score as an ABM

The Working group discussed the use of gait score as an ABM for different welfare consequences (locomotory disorders and restriction of movement). The working group agreed on using walking impairment as ABM using the gait score as a means of measuring the walking impairment.

5.3 Scientific Opinion: AHAW Panel comments

The Working group discussed and addressed the comments and questions posed by the EFSA AHAW Panel during the thorough reading on the SO Broilers. The conclusions and recommendations were discussed and agreed for space allowance, light, maximum group size, the provision of nests and litter.

5.4 Scientific Opinion: Conclusions and recommendations

The Working group reviewed the major conclusions and recommendations for the minimal enclosure.

5.5 Retro planning and task allocation

The working group agreed that the draft of the scientific opinion on welfare of broilers is submitted to the AHAW Panel for possible adoption on the 145th AHAW Panel. The remaining tasks and deadlines were identified to deliver the scientific opinion on time for the adoption AHAW Panel.

1. Welcome and apologies for absence

The Chair welcomed the participants.

2. Adoption of agenda

The agenda was adopted without changes.

3. Declarations of Interest of Working Groups members

In accordance with EFSA's Policy on Independence¹ and the Decision of the Executive Director on Competing Interest Management², EFSA screened the Annual Declarations of Interest filled out by the Working Group members invited to the present meeting. The minutes of the 23rd Working Group meeting were agreed by written procedure on 21st October 2022³.

5. Scientific topic(s) for discussion4

5.1 ABMs at slaughter

The ABMs at slaughter were revised by the working group members to conclude on the final ABMs. Discussions about how these ABMs should be calculated, recorded and reported were made by the working group along with considerations of the current technologies used to measure these ABMs.

5.2 Scientific Opinion: Characteristics of the minimal enclosure and uncertainty assessment

The Working group discussed possible conclusions and recommendations for the characteristics of the minimal enclosure for broilers and broiler breeders. The working group discussed minimum and maximum group sizes for broilers and for broiler breeders, as well as the space of the enclosure to prevent highly relevant welfare consequences such as restriction of movement and soft tissue and integument damage. In broiler breeders a special emphasis was made on the sex ratio to prevent welfare consequences of inability to avoid unwanted sexual behaviour. In addition, equipment such as tiers, perches and nests and recommended dimensions and materials were discussed.

The working group also discussed the characteristics of the outdoor range and the covered veranda for broilers.

5.3 Scientific Opinion: Heat stress

The working group revised and addressed the comments on the draft section of heat stress.

5.4 Scientific Opinion: Gastroenteric disorders

The working group addressed the comments on the draft section of gastroenteric disorders in broilers chickens in all husbandry systems.

5.5 Space allowance based on the behavioural approach

The behavioural approach to determine space allowance was revised and discussed by the Working group.

5.6 Scientific Opinion: Conclusion on minimum area and stocking density

The working group reached conclusions on the minimum area and stocking density that will prevent broilers and broilers breeding from experiencing several highly relevant welfare consequences.

5.7 Scientific Opinion: Impacts of genetics in broiler welfare

The working group discussed and agreed on the growing rates to determine if a certain broiler chicken belongs to the slower growing or fast-growing categories and how the genetics makes them more prone to certain welfare consequences.

5.8 Scientific Opinion: Comments by the AHAW Panel

The Working group discussed and addressed some pending comments and questions posed by the EFSA AHAW panel comments on the SO Broilers.

5.9 New structure of the scientific opinion

The new structure of the scientific opinion articulated by welfare consequence was discussed by the working group members. Comments were addressed and changes were made to improve consistency and readability. The new structure was approved by the working group.

5.10 Retro planning and task allocation

The remaining tasks and deadlines were identified to deliver the scientific opinion on time for the AHAW panel to revise the SO.

The Working group discussed possible conclusions and recommendations for housing systems for broilers. At first they discussed group size, stocking density, and the minimal dimensions (height and surface) needed inside enclosures. Afterwards, the amount, type, size and characteristics of litter, nests, perches, feeders and drinkers were revised. Information about environmental characteristics like temperature, gases and light was also reviewed and discussed as well as the use of covered verandas, free range and their features.

5.2 Scientific Opinion: Conclusions and recommendations of general ToRs Broilers

The Working group addressed the comments on the conclusions and recommendations of the welfare consequence cold stress.

5.3 Scientific Opinion: Space allowance estimation

The working group agreed on the proposed approach to estimate space allowance. The allocated working group members will draft the methodology and results.

5.4 Scientific Opinion: ABMs at slaughter

The working group discussed the ABMs at slaughter to measure broiler welfare on farm. Mortality was the ABM discussed by working group members and the draft will be used to articulate the other ABMs at slaughter which are: footpad dermatitis, wounds and carcass condemnation. A deadline for a first draft was agreed.

5.5 Scientific Opinion: Comments by the AHAW Panel

The Working group discussed and addressed some of the comments and questions posed by the EFSA AHAW panel comments on the SO Broilers.

Comments in the narrative draft were provided and a plan was made.

5.4 Scientific Opinion: Specific scenario 1c: The welfare of fast-growing chickens in barns and the risk associated with air quality

Comments in the narrative draft were provided and a plan was made.

5.5 Scientific Opinion: Specific scenario 3a: the welfare of broiler breeders and the risk associated with housing in (individual) cages

Comments in the narrative draft were provided and a plan was made.

5.6 Scientific Opinion: Specific scenario 3b: the welfare of broiler breeders and the risk associated with the practice of routine mutilation (beak trimming, detoeing, de-combing, de-clawing, ...)

Comments in the narrative draft were provided and a plan was made.

5.7 Scientific Opinion: Specific scenario 4: the welfare of day-old chick until they reach the rearing or breeding farms: hatchery conditions

Comments in the narrative draft were provided and a plan was made.

5.8 ABMs at slaughter (results of screening exercise)

The results of the screening filled by each expert individually were discussed in the group. The ranking of the scores according to the three criteria were discussed in the working group. Out of a list of initial 11 ABMs at slaughter, the Working group selected four ABMs at slaughter.

5.9 Comments by the EFSA AHAW panel on the SO

Some of the EFSA AHAW panel comments on the SO Broilers were discussed in the working group and addressed. The draft opinion will be presented to the AHAW panel on 21/22 September 2022. Possible adoption is planned for December 2022.

5.10 Scientific Opinion: Exercise on space allowance for broilers.

The new method of calculation of space allowance accounting for interindividual space was presented. The data extracted was revised.

5.11 Scientific Opinion – Timeline and retro-planning of the SO of the welfare of Broilers The tasks were distributed amongst the experts to meet the expected deadlines.

5.12 Scientific Opinion: Data extracted for space allowance estimation for laying hensThe calculations for space allowance for laying hens based on selected behaviours were discussed. Tasks were assigned to verify extracted data from the scientific literature to inform the calculations.

5.13 Scientific Opinion: Discussion on definition/ characteristics of minimal enclosure The WG discussed possible recommendations for housing systems for laying hens, pullets and layer breeders. This discussion will continue during the next meeting.

5.1 Scientific Opinion – Assessment of ABMs collected at slaughterhouses to monitor the level of welfare on broiler and laying hen farms

EFSA staff presented possible ABMs that could be collected at slaughterhouses ante-mortem and post-mortem to evaluate farm welfare. The proposed ABMs were subjected to a screening to four criteria: 1) had to be relevant to welfare, 2) directly related to the farm, 3) with existing literature sources and 4) also feasible to be measured at the slaughterhouse. If the ABMs fulfilled these criteria, they were retained for the next step of the assessment. Working group members voted yes/no, to decide which ones would be on the list to assess the level of welfare of laying hen and broiler farms.

5.1 Scientific Opinion - Pending items

The pending items that required Working group discussion were addressed.

5.2 Scientific Opinion - Planning of Specific scenarios 1, 2 and 4

The specific scenarios 1,2 and 4 were briefly presented and the deadlines were reminded to the working group.

The stocking density is expressed in kilograms per m² measured at the time of the assessment (up to five days before slaughter). For the evaluation of the FDP the average of a 3-level score within a flock is used. Step 1 of the EKE exercise - Median ABM under very high stocking density set to 30 – 42 kg/m² and Step 2: Low ABM under very high stocking density were facilitated by Olaf Mosbach-Schulz whereas Step 3: Median ABM with low stocking density and Step 4: Maximal stocking density without effect were facilitated by Hans-Herman Thulke.

In accordance with EFSA's Policy on Independence² and the Decision of the Executive Director on Competing Interest Management³, EFSA screened the Annual Declarations of Interest filled out by the Working Group members invited to the present meeting. No Conflicts of Interest related to the issues discussed in this meeting have been identified during the screening process, and no interests were declared orally by the members at the beginning of this meeting.

4. Agreement of the minutes of the 3rd Working Group meeting held on 5th February 2021, TELE-conference.

The minutes of the 3rd Working Group meeting were agreed by written procedure on 15th February 2021⁴.

5. Scientific topic(s) for discussion⁵

The WG members revised the most updated version of draft scientifc opinion including the latest contributions on the description of husbandry systems and main welfare consequences (WCs). Some common approaches in the layout were agreed to avoid repetition; (i) a detailed description on main welfare consequences will be provided at the level of the husbandry system where they are first described, and to refer to this first description when the same WC is relevant for other subsequent systems, also (ii) to create a separate section in the scientific opinion for non-system specific WCs such as prolonged hunger, so that it is described only once. With the support of the EFSA facilitator, the WG members discussed the proposed Expert Knowledge Elicitation (EKE) model approach to assess the relationship between exposure variables and the corresponding ABMs. The different specific scenarios from the terms of reference where introduced to the WG members as well as the methodology proposed to retrieve literature and to collect quantitative data, if available. The WG members agreed on a common approach to be followed for each specific scenario: (i) after a first exercise to ascertain if sufficient quantitative data is available in literature on the various exposure variables for the identified ABS, (ii) the WG members may propose to perform an EKE to retrieve expert knowledge on scenarios where the data retrieved is scarce.

This exercise consisted in i) combining the individual rankings from all WG members in a single file ii) discussion and final ranking for those welfare consequences where the assessment among members differ significantly ii) reaching an agreement on the clearly relevant (highest ranked) welfare consequences per husbandry system iii) providing a justification for their selection by expert's opinion on duration, severity and occurrence. During the last part of the meeting, the description on the main broilers husbandry systems provided by EFSA Broilers WG members was discussed. Some changes were suggested to be implemented before the next meeting, as well as the description of all welfare consequences under the respective systems.
