#### 5. Scientific topic(s) for discussion

#### 5.1. Draft opinion

The WG discussed the contributions addressing the comments received from AHAW panel members and pending comments raised by WG experts.

#### 5.2. Specific ToR 1

Remaining comments in the section answering specific ToR 1 on minimum enclosure were discussed as well as conclusions and recommendations. The recommendations for covered verandas and outdoor range were discussed and agreed, in part with certainty ranges.

The methodology and results of the model calculation was added to the draft opinion but not discussed.

#### 5.1. Specific ToR 2

Comment on specific ToR 2 on beak trimming were addressed. The concentration of text on beak trimming and injurious pecking in this section revealed some gaps on the ABMs for soft tissue lesions. It was agreed to add the iceberg indicator 'wounds' to the ABMs for soft tissue lesions. Conclusions and recommendations were discussed and agreed.

#### 5.2. Specific ToR 3

Comments on the specific TORs were discussed and agreed, There were only few comments by the panel which have been addressed.

The draft opinion will be presented to the panel for possible adoption on 14/15 December 2022.

#### 6. Next meeting

There are no further meetings planned. EFSA and EC described the next steps in the process to the WG.

### 4. Agreement of the minutes of the 23<sup>rd</sup> Working Group meeting held on 10<sup>th</sup> October 2022, web

The minutes of the 23<sup>rd</sup> Working Group meeting were agreed by written procedure on 17<sup>th</sup> October 2022.<sup>4</sup>

#### 5. Scientific topic(s) for discussion

#### 5.1. Specific ToR 1

The specific ToR 1 is addressed in parts. Part 1 provides an overview of welfare consequences on cage and non-cage systems for laying hens and Part 2 defines minimum requirements of enclosures for laying hens, pullets and layer breeders. This includes a discussion of access to covered veranda and/or outdoor range.

#### 5.2. Specific ToR 1: model calculation of space allowance

An update to the calculation of space allowance based on selected behaviours was presented. The behaviour that contributes most to the calculation of space needed is 'walking', followed by 'wing flapping' and 'foraging'. A sensitivity analysis was carried out to evaluate which factor contributes the most to the model outcome which will be included in the uncertainty analysis. The input for 'distance walking' and 'space walking' have largest effect on model outcome. The model outcome with associated uncertainty informs the conclusions on minimum area of enclosure and maximum stocking density.

#### 5.1. Specific ToR 2

An update was provided on the text on beak-trimming. It was decided to collect all discussion on beak-trimming in this section and refer to it when beak trimming is mentioned elsewhere.

#### 5.2. Specific ToR 3

An update was provided on ABMs collected in the slaughterhouse to assess welfare on farm. The draft text is well developed and will now be integrated into the draft opinion.

The WG discussed the general conclusions and recommendation on the welfare consequences and added certainty ranges to those with larger uncertainties.

An alternative structure was suggested for the draft opinion in order to reduce repetition and improve readability. Even though it is challenging to revise the structure at this stage, the WG decided to go ahead with the suggestion.

The comments from the AHAW Panel were discussed. The draft opinion will be presented to the panel for thorough reading during the next meeting 23/24 November and for possible adoption on 14/15 December 2022.

#### 5. Scientific topic(s) for discussion

#### 5.1. Data extraction and calculation of space allowance

An update to the calculation of space allowance based on selected behaviours was presented. The behaviour that contributes most to the calculation of space needed is 'walking', followed by 'wing flapping' and 'foraging'. A thorough discussion on the data sources for these behaviours followed to validate the calculations. It was agreed that a sensitivity analysis may be useful and that an uncertainty analysis needs to accompany the model results to provide useful conclusions. This will be followed up during the next WG meeting.

#### 5.2. Discussion on specific scenario 1

For specific scenario 1, a table was developed to compare conventional and alternative husbandry systems. In addition, minimum requirement for enclosures for laying hens, pullets and breeders are described. The WG did not conclude on minimum total area, group size and stocking density. Other requirements on environment and management were defined, such as elevated platforms, litter and nests. The discussion will continue during the next WG meeting.

#### 6. Next meeting

The next WG meeting will be held on 3<sup>rd</sup> and 4<sup>th</sup> November 2022.

#### 5. Scientific topic(s) for discussion

#### 5.1. Behavioural needs, priorities and preferences

The definitions of the terms "behavioural need, "priority" and "preference" were clarified, and it was agreed that for the purpose of the scientific opinion, the terms "need" and "preference" were sufficient. "Priority" being part of "needs" are addressed and don't need to be distinguished.

#### **5.2.** Data extraction and calculation of space allowance

An update to the calculation of space allowance based on selected behaviours was presented. There are limited data for laying hens but the WG agreed that the approach is valid nevertheless and certainty ranges can be provided, if needed. and tasks were assigned to verify extracted data from the scientific literature to inform the calculations.

#### 5.3. Discussion on the General TORs of the scientific opinion<sup>5</sup>

The WG discussed the comments from the AHAW panel and the draft conclusions and recommendations. It was agreed that a general recommendation could be added promoting the concept of positive welfare in future welfare assessments. The panel comments will be addressed until the next WG meeting.

#### **5.4.** Discussion on specific scenarios

For specific scenario 1, a table was developed to compare conventional and alternative husbandry systems. In addition, minimum requirement for enclosures for laying hens, pullets and breeders will be described. For specific scenario 2, the effect of beak trimming and non-beak trimming and effect on welfare are described. For specific scenario 3, ABMs were selected that could be measured at slaughter to assess welfare at farm. A literature search is conducted on those ABMs.

The drafting of the sections on the specific scenarios was assigned to experts and will be discussed during the next WG meeting.

A presentation was provided on a tool used to calculate the space required to perform 11 behaviours (broilers and laying hens) based on data extracted from literature. The working group members agreed to identify additional data on positive welfare indicators to further fine tune the calculation of space allowance for broilers and laying hens. These results will complement the results of the expert knowledge elicitation (EKE).

### 5.3 Conclusions and Recommendations on Welfare consequences: 'Resting problems' and 'Exploratory and foraging behaviour':

Working group members discussed pecking and scratching material and the minimal size of perches for broilers and laying hens agreed to recommended elevated structures for all husbandry systems.

The WG concluded that stocking density is not the only factor relevant for the occurrence of foraging behaviour. This will be reflected in the Scientific Opinion.

The evidence dossier on the first ABM on plumage damage in relation to stocking density was discussed. Definitions were agreed and the EKE questions defined.

Stocking density was defined as indoor space measured in bird/usable  $m^2$  ('usable' defined as in Directive 1999/74/EC). Outside areas are excluded. 3-D housing is considered and converted in flat area for the EKE.

Plumage damage was defined as 'Deterioration or loss of plumage due to the action of other birds scoring neck, back & rump and belly' and scored on a 3-point scale.

Four questions were elicited: average plumage score for non-beak trimmed flocks in low stocking density, beak-trimmed and non-beak trimmed flocks in high stocking density, and maximum stockage density without effect on plumage score.

The ranking exercise initiated in the previous meeting to identify the most relevant welfare consequences per each husbandry system was completed for pullets. An assessment of the overall picture of the entire ranking in laying hens, breeders and pullet's husbandry systems was made to ensure the harmonization of the result across species. Further discussion is needed.

The overall structure of the draft scientific opinion on the welfare of laying hens was agreed in regard to the classification of husbandry systems for laying hens, pullets and breeders; draft text was revised for the description of some husbandry systems. Further discussion is needed.

The first part of the meeting was held jointly with the members of the EFSA Broiler WG; *i*) the list of welfare consequence, revised by the EFSA AHAW Task Force, was presented and some amendments were proposed e.g. to incorporate predation stress, *ii*) the methodology to rank and identify the most relevant welfare consequences per husbandry system was explained and *iii*) a full example to apply this methodology was conducted for one husbandry system. During the second part of the meeting, for all the remaining laying hen husbandry systems, the EFSA Laying Hens WG performed the first part of the ranking exercise. This consisted in excluding the non-applicable welfare consequences for these systems and preparing the basis for ranking the relevant ones. Relevance is to be assessed by expert's opinion following judgement on duration, severity and occurrence of welfare consequences in those husbandry systems.
