It was agreed that:

- (i) it will not be possible to do a systematic literature review due to the limited timelines of this mandate and available resources;
- (ii) efforts will be made to follow a structured approach to still perform an extensive literature search;
- (iii) the relevant search string will be refined and a draft protocol prepared defining eligibility criteria for the screening phase;
- (iv) the AMU Unit will assist the *Bacillus* WG allocating the needed Distiller licenses to the WG members performing the literature search, training these on the use of the tool and guiding them when necessary on the followed approach.

The PRAS Unit presented their outsourced literature reviews in this area as well as the structure of the Draft Assessment Reports (DARs) provided for previous evaluation of *B. thuringiensis* plant protection products in EFSA in the context of the Pesticides' peer-review process. It was agreed to: (i) share one DAR with the WG to identify possible relevant sections that could be also checked in the other DARs; (ii) organise a technical consultation with representatives of the International Biocontrol Manufacturers Association (IBMA) and the questionnaire drafted by EFSA for this purpose was carefully reviewed, (iii) complement this technical consultation with the consultation of the Member States via PRAs network using a similar questionnaire.

The Working Group discussed thoroughly the terms of reference with the European Commission and agreed on approaches to answer these. It will not be possible to do a quantitative evaluation of the risk to public health
