#### 5.1. Scientific Opinion on the update of the list of QPSrecommended biological agents intentionally added to food or feed as notified to EFSA<sup>5</sup>

Feedback from the previous BIOHAZ plenary (September) on the current draft opinion was provided by the chair to the WG. In reply to the suggestions received, some clarifications were included in the background of the document (for instance, on the purpose of the QPS exercise which is only intended for regulated products and for internal use by some EFSA Units). The experts went through the draft opinion and initially discussed the "Introduction" and "Data and methodology" chapters. The four EFSA Units for which the QPS assessment is done (Feed, FIP, Pesticides and Nutrition) were also invited to participate in the discussion in a dedicated point of the meeting Agenda to clarify some pending issues with the experts related to the OPS assessment. The "Assessment" chapter where the evaluations of the previous QPS recommendations and respective qualifications are included was thoroughly discussed. The structure of the different aspects considered for each specific assessment was revised and harmonised. The draft conclusions were also discussed by the experts. Some small pending issues will be sorted out by email after the meeting but in general the WG is satisfied with the current version.

Lessons were discussed and extracted from the extensive literature search (ELS) exercise run during this QPS mandate that will be compiled for the improvement of future exercises for the same purpose.

This Opinion will be presented to the BIOHAZ Panel for thorough reading at the plenary in October and for possible adoption at the plenary in December of 2016.

# 5.2. Statement on the update of the list of QPS-recommended biological agents intentionally added to food or feed as notified to EFSA 5: Suitability of taxonomic units notified to EFSA until March 2016<sup>6</sup>

The list of microorganisms notified to the four EFSA Units (Feed, FIP, Pesticides and Nutrition) has been again updated. From all notifications received since March 2016 until the beginning of September, three microorganisms were evaluated for a possible QPS recommendation. The evaluation of the respective taxonomic units was finalised by the experts. Some small pending issues will be sorted out by email after the meeting but in general the WG is satisfied with the current version.

The experts went through the current draft opinion and further improved the introduction and methodology chapters. The four EFSA Units for which the QPS assessment is done (Feed, FIP, Pesticides and Nutrition) have been once more asked to also revise those chapters. Pesticides Unit participated in a dedicated point of the meeting Agenda in order to discuss some pending issues with the experts related to the pesticides regulatory framework and the QPS assessment. The Units will be asked again to revise the draft opinion, on the aspects linked to the specific regulatory frameworks, the type of assessments developed and the usefulness or limitations of the QPS assessment.

The state of the art of the ELS process was presented. The article evaluation phase is almost finished and only a few conflicts are to be settled. The plan for the follow up ELS was presented by AMU to the experts. Experts will start revising the previous recommendations for the QPS status and respective qualifications.
