MEETING MINUTES – 13 May 2024 1st Working Group meeting on the equivalence of an alternative attreatment process of feathers and down

The Canadian Food Inspection Agency (CFIA) asked the EC to assess an alternative method for the export of treated feathers to the EU. In the sequence of this request, the EC requested EFSA to provide a scientific opinion concerning the equivalence of the heat treatment process of feathers and down consisting of dry heat to a temperature of 100°C or higher for at least thirty (30) minutes, with the treatment set up in Chapter VII, Point C of Annex XIII to Regulation (EU) No 142/2011, in terms of inactivation of relevant pathogens. The latter defines an end point for feathers and down which have been factory-washed and treated with hot steam at 100°C for at least 30 minutes.

The BIOHAZ Panel already evaluated the level of reduction of relevant pathogens using a similar treatment procedure for feathers and down in 2021 within a previous opinion published in 2021 ("Inactivation of indicator microorganisms and biological hazards by standard and/or alternative processing methods in Category 2 and 3 animal by-products and derived products to be used as organic fertilisers and/or soil improvers"). It will be used as a basis for this opinion.

The approach and protocol will need to be prepared for approval during the next BIOHAZ Panel plenary in June.

The chair gave feedback to the working group on the presentation of the draft opinion for the first time at the 153rd plenary of the BIOHAZ Panel, held on 3-4 May 2022. The main points were the lack of clear standards to be applied to Category 3 animal by-products, the implementation of a proper hazard identification vs. selection of a pathogenic microorganism known to be resistant as primary target and the possibility to stop the clock and ask for improvements in the dossier to the applicant. The Panel recommended EFSA to review and update the EFSA's "Statement on technical assistance on the format for applications for new alternative methods for animal by-products" (2010) and request additional information while the clock is stopped. The working group discussed and agreed to request changes in the dossier. The comments by Panel members and the different sections of the draft opinion were reviewed and a number of actions were agreed.

4.1 Scientific opinion on the request for the evaluation of an alternative method for the production of renewable fuels using Category 3 animal fat and used cooking oils by BP-Rotterdam (EFSA-Q-2021-00625)⁵

The EFSA provided an update on the reply by the applicant to the request for additional information. A new dossier was submitted. Following the uncertainty about the standard methods to be applied to use cooking oils before processing, EFSA contacted the EC asking for clarification. The standards for equivalence of alternative methods for processing Category 3 ABP were discussed. Several options were discussed, and the decision was to reduce the concentration of the relevant pathogenic bacteria by at least 5 log₁₀ and the infectious titre of the relevant viruses by at least 3 log₁₀. The draft opinion was reviewed with the first draft of the sections concluding the assessment of the dossier. The Hazard identification, level of risk reduction, the HACCP and the risks of interdependent processes were the four sections discussed in more depth. EFSA continues dealing with the confidentiality claim, in liaison with the Legal Department.

The Chair thanked the participants and closed the meeting.

4.1 Scientific opinion on the request for the evaluation of an alternative method for the production of renewable fuels using Category 3 animal fat and used cooking oils by BP-Rotterdam (EFSA-Q-2021-00625)

The original dossier submitted in October 2021 was presented by EFSA secretariat, with the missing information requested to the applicant following the completeness check, namely, the hazard identification, the generic description of the processing method, the risks associated to the interdependent processes and of the end use of the product, the confidentiality claim and the mark "draft" in the first version of the dossier. The final and validated dossier received on 31 January 2022 was then presented, highlighting the differences with the original. The main aspects of the application were discussed, and it was agreed to ask the applicant for clarification on the by-products of pretreatment steps of the process, the critical control points of the HACCP plan, and adding the clarification about the category of used cooking oils, according to Reg (EC) 1069/2009. It was decided to contact the applicant and not to stop the clock since the assessment can progress while this information is provided by the applicant. The confidentiality claim is being dealt with by the Legal Department and it was agreed that it would be better to contact the applicant separately on this issue. The scientific opinion must be delivered by 9 August 2022.

5. Any Other Business

The Chair thanked the participants and closed the meeting.

4.1 Scientific opinion on the request for the evaluation of an alternative method for the production of renewable fuels using Category 3 animal fat and used cooking oils by BP-Rotterdam (EFSA-Q-2021-00625)⁵

The chair gave feedback to the working group on the presentation of the draft opinion for the first time at the 153rd plenary of the BIOHAZ Panel, held on 3-4 May 2022. The main points were the lack of clear standards to be applied to Category 3 animal by-products, the implementation of a proper hazard identification vs. selection of a pathogenic microorganism known to be resistant as primary target and the possibility to stop the clock and ask for improvements in the dossier to the applicant. The Panel recommended EFSA to review and update the EFSA's "Statement on technical assistance on the format for applications for new alternative methods for animal by-products" (2010) and request additional information while the clock is stopped. The working group discussed and agreed to request changes in the dossier. The comments by Panel members and the different sections of the draft opinion were reviewed and a number of actions were agreed.

The minutes of the 5th Working Group meeting held on 24 February 2022 were agreed by written procedure on 1 March 2022.

5. Scientific topic(s) for discussion

4.1 Scientific opinion on the request for the evaluation of an alternative method for the production of renewable fuels using Category 3 animal fat and used cooking oils by BP-Rotterdam (EFSA-Q-2021-00625)⁵

The EFSA provided an update on the reply by the applicant to the request for additional information. A new dossier was submitted. Following the uncertainty about the standard methods to be applied to use cooking oils before processing, EFSA contacted the EC asking for clarification. The standards for equivalence of alternative methods for processing Category 3 ABP were discussed. Several options were discussed, and the decision was to reduce the concentration of the relevant pathogenic bacteria by at least 5 log₁₀ and the infectious titre of the relevant viruses by at least 3 log₁₀. The draft opinion was reviewed with the first draft of the sections concluding the assessment of the dossier. The Hazard identification, level of risk reduction, the HACCP and the risks of interdependent processes were the four sections discussed in more depth. EFSA continues dealing with the confidentiality claim, in liaison with the Legal Department.

6. Any Other Business

The original dossier submitted in October 2021 was presented by EFSA secretariat, with the missing information requested to the applicant following the completeness check, namely, the hazard identification, the generic description of the processing method, the risks associated to the interdependent processes and of the end use of the product, the confidentiality claim and the mark "draft" in the first version of the dossier. The final and validated dossier received on 31 January 2022 was then presented, highlighting the differences with the original. The main aspects of the application were discussed, and it was agreed to ask the applicant for clarification on the by-products of pretreatment steps of the process, the critical control points of the HACCP plan, and adding the clarification about the category of used cooking oils, according to Reg (EC) 1069/2009. It was decided to contact the applicant and not to stop the clock since the assessment can progress while this information is provided by the applicant. The confidentiality claim is being dealt with by the Legal Department and it was agreed that it would be better to contact the applicant separately on this issue. The scientific opinion must be delivered by 9 August 2022.
