Furthermore, it was also reminded that these meetings are scientific fora where only scientific discussions are taking place.

4.2. Workshop preparation

The participants welcomed the possibility to participate to a face-to-face workshop in the middle of June, pending confirmation due to the current worldwide sanitary situation. Because of this reason, the location of the workshop is to be considered carefully (possibility of cancelation and back-up plan). The duration of the meeting was favoured for 1.5 days to allow appropriate rest, keep concentration high and the possibility of networking.

4.3. EFSA external report on *in vitro* protein digestibility

The EFSA external report on *in vitro* protein digestibility⁶ was presented by the contractor (only at the meeting for the presentation). EFSA thanked the contractor for the availability.

4.4. Draft statement on *in vitro* protein digestion

The draft statement on *in vitro* protein digestion in the risk assessment of GM plants was introduced by the Working Group. Participants provided comments on topics addressed in the document that were discussed in detailed during the meeting. The Working Group will take into considerations the comments received and will produce a new document for adoption by the EFSA GMO Panel by the end of 2020/beginning of 2021.

4.5. Conclusions and next steps

EFSA thanked all participants for the contributions to this meeting. Further discussions will take place with the Stakeholder consultative group and relevant hearing experts next year where the scientific
